- 2.) Embryo Transfer fees: Donor Mare Management \$500/cycle Fresh/Cooled and \$550/cycle Frozen, Mare Lease and Pregnancy Fee: \$3250/pregnant recipient. If the Mare Owner is providing own recipient then Pregnancy Fee only will be applied. Additional cycles if no embryo recovered will be \$300/cycle.
- 3.) The Donor Management fee will cover all rectal palpations, reproductive ultrasound scans, and artificial inseminations for one cycle embryo flush and transfer, palpation of recipient mare up to 60 days of pregnancy for the 2022 breeding season. All other veterinary reproductive procedures such as intrauterine cultures, hormone injections, uterine lavage/infusion and any other medication administered or treatments deemed necessary or appropriate will be billed to the Mare Owner/Lessee. The breeding season opens February 14th and closes July 8th. Donor mares are to be vaccinated within the last 6 months prior to arrival at SVS against the following: EEE, WEE, Tetanus, Influenza, Equine Herpesvirus, and West Nile Virus. Strangles vaccination is recommended, however not required. If the mare has not been vaccinated prior to arrival, Sage Veterinary Services will vaccinate at mare owner's expense.
- 4.) Pregnancy ultrasounds will be performed on days 14, 16, 25, 35 and 60 days post-ovulation. Mares, which have departed SVS prior to reaching 60 days in foal, can return to SVS for these ultrasonic exams. All other pregnancy exams will be charged at the normal rate. Recipient mare hormonal treatments will be included while on SVS property through the 25 day heart beat check. After this time, the Mare Owner/Lessee will be charged \$2.30/day. Live foal guarantee begins after 35 days in foal. If recipient mare fails to produce a live foal after being checked in foal at 35 days, mare owner is entitled to a decreased pregnancy fee/lease fee (\$2250) for the subsequent season. This will only be available on the subsequent season from the start of this contract.
- 5.) SVS agrees to provide board, feed, and general care services for the Mare covered in this agreement. Feed includes grass or alfalfa hay, equine senior or sweet feed grain. Supplements or other specific types of feeds will be the responsibility of The Mare Owner/Lessee to supply SVS. The Mare Owner/Lessee agrees to pay SVS's published rates, which shall not be increased without thirty days prior notice thereof. All board and accumulated fees will be due prior to the mare leaving SVS's facility. SVS's present rates are as follows:

Paddocks \$ 15.00/day Dry Mare
Paddocks wth shelter \$17.00/day Mare with foal
Foaling Fee \$ 450.00

Covered Stalls \$24.00/day Dry Mare Covered Stalls \$26.00/day Mare with Foal Recipient Mare Board (after 16d Pregnancy) \$9.00/day

- 6.) Mare Owner/Lessee agrees that he/she has made him/herself familiar with the facilities at SVS and approves of the care provided. Other services that are required or desired by Mare Owner/Lessee, shall be specified in writing to SVS when the Mare is delivered.
- 7.) Mare Owner/Lessee authorizes SVS to provide any veterinary services necessary or proper for the Mare or her foal's well being at the expense of Mare Owner/Lessee. SVS agrees to attempt to contact Mare Owner/Lessee at the numbers listed below should any emergency with the Mare or her offspring occur. All veterinary procedures and/or medications will be billed to The Mare Owner if the need arises and will be due upon receipt. **Please check box below, which applies.** No box marked means the Mare Owner/Lessee accepts SVS's decision.
- [] Should communication with Mare Owner/Lessee not be established and emergency surgery, such as colic surgery, at a minimum cost of \$8,000.00 be necessary, Mare Owner/Lessee authorizes this surgery.
- [ ] Should communication with Mare Owner/Lessee not be established emergency surgery is not to be performed.



- 8.) Recipient Mares are the property of Ben and Hallie Noland. Mare Owner/Lessee is leasing the recipient mare for her surrogate services. Mare Owner/Lessee is responsible for returning the Recipient Mare no later than December 31 of the foaling year to Ben and Hallie Noland. If the Recipient Mare is NOT returned by December 31 of the foaling year or dies while in the Mare Owner/Lessee care, Mare Owner/Lessee agrees to pay \$1500.00 for replacement of the Recipient Mare. The Recipient Mare can be purchased from Ben and Hallie Noland at a fee of \$1500.00 if Mare Owner/Lessee should decide to keep the mare.
- 9.) Mare Owner/Lessee agrees that SVS and its employees will not be held responsible for accidents, injury, sickness or death to the Mare and/or foal and that likewise Mare Owner/Lessee will not be responsible for any accident, injury, sickness or death to the stallion, other horses, or SVS employees.
- 10.) ALL CHARGES AND FEES INCURRED IN CONNECTION WITH THE MARE/FOAL MUST BE PAID IN FULL PRIOR TO THE MARE DEPARTING FROM SVS. MARE/FOAL WILL NOT BE DISCHARGED FROM SVS UNTIL ALL CHARGES ARE PAID.
- 11.) Statements of outstanding fees are mailed at the end of each month. If the outstanding balance is 60 days past due, a interest fee of 1.8% per month will be applied to all charges. If paying by credit card, a 3.75% processing fee will be assessed.
- 12.) SVS shall attempt with reasonable diligence to settle the Mare and collect an embryo: if however, for any reason the Mare does not settle or no embryo is recovered, Mare Owner/Lessee will hold SVS harmless.
- 13.) Neither Hallie Noland DVM, Benjamin Noland DVM, Kirk Shiner DVM, SVS, the Stallion Owner nor any of their representatives shall be liable to the Mare Owner/Lessee or any other person for the failure of the mare to produce a live foal for any reason whatsoever.
- 14.) This contract is effective when signed by both parties, and is not transferable or assignable.
