## 2022 COAL TRAIN FAME BREEDING CONTRACT

Mare owner hereby agrees to breed their mare \_\_\_\_\_\_\_\_ (please circle) AQHA, TB, APHA, registration
#\_\_\_\_\_\_\_\_\_ to the stallion COAL TRAIN FAME utilizing cooled or fresh semen. A stud fee of \$1,500.00 will be paid in full
to Suhn Performance Horses prior to any semen being shipped. Stud fee includes \$600 non-refundable chute fee as well as first shipment of
cooled semen OR first two cycles vet work at Sage Veterinary. A \$250.00 fee will be required with each additional shipment sent in the 2022
breeding season to Sage Veterinary Services. Sage Veterinary Services will reserve the right to make any minor adjustments to shipping charges
as necessary. Sage Veterinary Services will apply a 3.75% processing fee on all credit card transactions. The mare owner is responsible for the
cost and timely return of the shipping container to Sage Veterinary Services. Should the mare be brought to Sage Veterinary for on site
reproduction services a "Mare Care" fee will be charged at \$15/day for a Dry Mare and \$17/day for a Wet Mare.

- 2. Sage Veterinary Services will collect stallions Monday, Wednesday, and Friday. Breeding season will end June 15th of the year on this agreement. Stallion collection time is 10 a.m. MST. Sage Veterinary Services must be notified the evening prior to or by 9 a.m. MST the morning of collection to guarantee shipment. Sage Veterinary Services or Suhn Performance Horses shall not be responsible for the COSTS arising from shipments lost, damaged, or delayed in transit, or condition of cooled shipped semen upon delivery. We have no control of the shipment after it leaves our custody.
- 3. The mare owner represents the mare is healthy and in sound breeding condition and registered with the designated registration organization. The mare owner agrees to furnish a copy of the mare's registration papers, the shipped semen form, and any other information as Suhn Performance Horses requests. Thoroughbred mares must be registered with the AQHA to register foals.
- 4. When complete payment is made of \$1,500.00 to Suhn Performance Horses, this contract provides for the return breeding, in the succeeding year only, for this mare (or agreed substitute) that fails to produce a live foal to stand and nurse. Suhn Performance Horses must receive a certification by a licensed veterinarian within 10 days of the occurrence. A "Rebreed" may be satisfied in only the year following the date this contract was entered at the sole option to Suhn Performance Horses. Mare owner will be responsible for the "non-refundable rebreed fee" of \$600 payable to Sage Veterinary. "Rebreed Fee" will include the first shipment of semen OR first cycle vet work on mare at Sage Veterinary.
- 5. The mare owner agrees to use the semen shipped solely to breed the designated mare in accordance with the breeding contract and registry rules.
- 6. It is further agreed that, within the first year of this contract, should the above named stallion die or become unfit for service, or if my mare should die or become unfit to breed, then this contract shall become null and void, and any money paid as part of the stallion breed fee, except the included Chute fee of \$600 or any additional used shipping fees, shall be refunded to the mare owner if mare is not bred before said occurrence(s). If the above named stallion dies or becomes unfit for service, or if my mare should die or become unfit to breed, in the rebreed year of this contract this contract shall be considered fulfiled and all fees apply.
- 7. When the mare owner, or authorized representative, signs and returns this contract to Suhn Performance Horses, it will be a binding contract to both parties, subject to the above terms and conditions. This contract is not transferable or assignable. The mare owner/lessee agrees to pay all reasonable attorney fees incurred by Suhn Performance Horses in attempting to collect any outstanding balance. The mare owner irrevocably agrees that the mare owner's sole recourse against Suhn Performance Horses with respect to the performance or non-performance of this breeding contract is a return of the stud fee in and of itself.
- 8. The breeder's certificate will be issued upon notification that the mare has foaled and all debts have been paid.
